MOST WORK FOCUSED ON DISEASES CAUSED BY PROPAGATION OF PROTEIN MISFOLDING THAT INCLUDE FRONTOTEMPORAL DEMENTIA AND ALZHEIMER'S, PARKINSON'S, HUNTINGTON'S, AND PRION DISEASES.
